# 2025 LAW ENFORCEMENT COLLECTIVE NEGOTIATIONS SEMINAR

The renamed Collective Negotiations Seminar will be held at the Tropicana Resort Atlantic City, 2831 Boardwalk, Atlantic City, NJ 08401. It will begin Tuesday, February 4<sup>th</sup>, 2025, with lunch immediately after the State PBA meeting until 4:00 PM. Seminar will continue Wednesday (2/5) and Thursday (2/6) beginning at 8:30 AM until 4:00 PM. Check-in will begin before the State PBA meeting at the Grand Exhibition Center in the South Tower Grand Concourse.

Seminar registrations should be submitted by **Friday, January 3<sup>th</sup>**, 2025. Each Local will receive an invoice for **\$350.00** per participant for first 2 members of the Local. Additional members from the same Local are **\$325 each**. The seminar includes lunch on Tuesday and continental breakfast and lunch for Wednesday and Thursday. **Payments received after January 3<sup>rd</sup>, 2025, will be \$425.00 with no Local volume discount.**
